STAGES OF THE APPLICATION PROCESS:

1. Initial Application (Submitted to the Chief Deputy)
2. Review of application by Administrative Committee (Chief Deputy, and Division Captains)
3. Oral Interview with Chief Deputy and Three Division Captains
4. Formal Application (Completion of Sheriff's Training & Standards Commission's F3, Personal History Statement)
5. Evaluation and Review of Formal Application with Recruiting Division
 - 6) Pre-Conditional Offer of Employment Testing
 - Pre-Employment Physical Agility Test
 - Pre-Employment Police Officer Selection Test (POST)
 - Pre-Employment Firearms Qualification
 - 7) Background Investigation
 - Oral Interview with Sheriff
 - 8) Post-Conditional Offer of Employment
 - Medical Evaluation
 - Polygraph Examination
 - Mandatory Drug Screening
 - Comprehensive Evaluation

JOB DESCRIPTION/BENEFITS:

The Cabarrus County Sheriff's Office employs 185 sworn deputies and 9 civilians. Cabarrus County is among the top ten counties in North Carolina for growth and population. As deputy trainee, you will be paid full salary while receiving comprehensive training through the Rowan Cabarrus Community College's Basic Law Enforcement Training Program. Upon completion of the recruit training, you will be responsible for protective services work as well as the prevention, detection, and investigation of crimes. **This work may involve personal risk and requires sound judgement.**
