## RESIDENTS OF CABARRUS COUNTY AS OF JANUARY 1 MUST USE THIS FORM TO LIST PERSONAL PROPERTY

Section A - Name and Address: Complete section and make changes as necessary in spaces provided.

<u>Section B</u> - Real Estate: New Construction, Improvements or Demolitions. Complete this section if you had any new construction or made improvements to your property during the prior calendar year by describing the improvement to property and 100% of cost as of January 1. Under EXPECTED FINAL TOTAL COST, include costs incurred year to date and all estimated future costs to complete project (Total Project Cost). For questions call 704-920-2126.

Section C - Vehicles & Trailers: Untagged, multi-year tagged or IRP tagged vehicles (autos, trailers, campers, motorcycles, etc.) owned as of January 1 are required to be listed. Do NOT list annually tagged vehicles (where tax is paid at time of tag renewal.) Please provide complete information and 100% of cost. Mark DEL (DELETE) reason if not owned Jan. 1 (S=Sold, C=out of County, D=Disposed). For questions call 704-920-2166.

<u>Section D</u> - Watercraft: List all boats, boat motors, and jet skis as of January 1. Complete all information for property including 100% of cost. Mark **DEL** (**DELETE**) reason if <u>not owned</u> Jan. 1 (**S**=Sold, **C**=out of County, **D**=Disposed). For questions call 704-920-2166.

Section E - Mobile Homes: List all mobile homes as of January 1. Complete all information for property including 100% of cost. Mark DEL (DELETE) reason if not owned Jan. 1 (S=Sold, C=out of County, D=Disposed). For questions call 704-920-2166.

<u>Section F - Farm Machinery:</u> Enter farm machinery at 100% cost by year acquired and itemize all motor equipment (tractors, etc) only if used for the production of income or in connection with a business. Attach additional schedules if necessary. Mark **DEL (DELETE)** reason if <u>not owned</u> Jan. 1 (**S**=Sold, **C**=out of County, **D**=Disposed). For questions call 704-920-2166.

<u>Section G</u> - Aircraft: List all Aircraft including Airplanes, Ultra lights, and Hot Air Balloons, primarily stored overnight within the county. Complete all information including 100% of cost. Mark **DEL (DELETE)** reason if <u>not owned</u> Jan. 1. (**S**=Sold, **C**=out of County, **D**=Disposed). For questions call 704-920-2166.

<u>Signature</u>: This form must be signed and dated by the person whose duty it is to list the property and affirm accuracy of the listing. **Any individual who willfully makes a listing which they do not believe to be true and correct as to every material matter shall be guilty of a Class 2 misdemeanor per <b>NCGS 105-310.** Mail your tax listing by January 31 to avoid a 10% late list penalty. Your listing must be postmarked no later than January 31. Any other indication of the date mailed (such as your own postage meter) is not considered and the listing shall be deemed filed when received in the County Assessor's office. An extension of time to April 15 may be granted provided a written request showing good cause is filed with the office before January 31.
